The phrase a" New World Order" can mean different things depending on who you ask. In recent history the individual who said this phrase was Mikhail Gorbachev (the last leader of the USSR); then George H. W. Bush changed its meaning and tried to enforce it (his son, George W. Bush, agreed with him and also tried to enforce it). Many people, namely conservatives, have a set understanding of what this phrase means so they fear a good "New World Order" where there is freedom and instead they encourage an oppressive one. Donald Trump wants the oppressive "New World Order" and he will soon have it.

World Systems

Globalism/multilateralism is a belief that all the nations of the world should be in alliance. People that say they are Globalist believe that all the nations should be working together; this prevents wars and dictatorial nations. Globalism today can be seen in the form of the United Nations (UN), the European Union (EU) and other alliances. Some people believe the conspiracy theory that Globalism/multilateralism is evil- but in actuality, it is a good thing.

Bilateralism is a way the world can operate. In bilateralism two superpowers are in control and all, or most, of the other nations fall in one of those two camps. The two superpowers usually are hostile to each other and they compete to be number one. A bilateral world is not the best because only two countries really have any power and all of the others have to listen to one of them.

Unilateralism is when one single nation is in control of everyone- EVERYONE. It can be understood if we break the word itself up in two: uni and lateralism. Uni means one; so obviously, unilateralism is when one thing is in control- in this case one nation in charge of the world.

Mikhail Gorbachev's New World Order

In the time period around 1989, Gorbachev saw that the Soviet Union was falling. He knew that when the USSR fell, the United States wouldn't have any restraint and would rise up as a global dictator. To prevent this, Gorbachev introduced a" New World Order". He wanted the United Nations to have more power and thus unite the United States more closely with other nations. Even though his plan failed, Gorbachev continued to hold his view of a world working together.


George H. W. Bush's New World Order

George H. W. Bush became president in 1989. We know that 1989 is the fulfillment of Daniel 11:40b; at that time the King of the South: the USSR, began to fall although it had been weakening previous to this. The USSR had received a deadly wound and it died in 1991. In this time Bush heard of Gorbachev's idea of a "New World Order"- a multi polar world, and he did not like it, he wanted the world to be unilateral. Pre 1989/1991

the world had been bilateral and as the USSR fell Bush wanted the USA to take all its power, and become the only world superpower. So he changed the phrase a "New World Order" to mean a unilateral world where the USA was in charge of everyone.

How George H. W. Bush demonstrated his plan

Soon, after this, George H. W. Bush found a chance to demonstrate what he meant by a "New World Order". There is a little country in the Middle East called Kuwait and it is next to Iraq. Previously Iraq elected a new leader, Saddam Hussein; Iran elected a new leader too. The two leaders hated each other so there was war. Kuwait lent Iraq money to fight, but when the war was over and Iraq had won they told Kuwait that they would not repay them. Saddam Hussein thought that he had fought for the good of the whole Middle East so he didn't think he owed anyone. He also told Kuwait to pay them (Iraq) back for all the oil they had stolen from them while they were occupied in the war with Iran. Kuwait refused. On August 2, 1990 Iraq invaded Kuwait and quickly took over the capital. Now Saddam Hussein was in charge of a lot of the world's oil and this made George H. W. Bush scared- he determined to invade Iraq. But the people of the United States didn't want to go to war so with the help of Kuwait a lie was made that said Iraqi soldiers were killing babies and robbing hospitals. This made the people of the United States agree to a war with Iraq, and in January of 1991 the USA invaded Iraq, thus beginning the first Iraq War. Bush was using the USA's power to enforce his views, he was acting unilaterally.




George W. Bush's New World Order-the same as His father's

George W. Bush, just like his father, the late George H. W. Bush, believed in a unilateral world system with the United States on top. They believed there was no substitute for the American way.

How George W. Bush demonstrated his and his father's plan

Gorbachev brought the phrase "New World Order" to popularity, George H. W. Bush changed it to mean "unilateral USA", and his son, George W. Bush gave the world a taste of it through the second Iraq war. Long before September 11, 2001, Bush had wanted a war with Iraq. When 9/11 happened, he used it as an excuse to invade Iraq- not a cause. He did so without the permission of the UN and with other nations telling him not to do so. He didn't care what they said- he would have his war with Iraq no matter what. In 2003, when the United States invaded Iraq, everyone saw what the world would be like under unilateral USA. This was the second time the United States acted like a global policemen, and it surely wasn't the last.



What made the USA lose its status as the world leader?

The USA was the only superpower after the fall of the USSR but now it is not. This is because of two powers: radical Islam and Russia. After 9/11 radical Islam began to emerge and this made the USA start to have to deal with it and not focus on being the only world superpower. Also Vladimir Putin came to power in Russia in 1999 and he began to strengthen Russia, again. Prophetically Russia resurrected; and it again became a world superpower. These two things hindered the USA from being the one world superpower since 1999.

Donald J. Trump's New World Order

Donald J. Trump is also for unilateralism. He believes that the United States should be first. He doesn't like the United Nations, the European Union, or NATO- he doesn't like multilateralism. He is a nationalist who wants to make America great but doesn't care about what happens to other countries. He is for the "New World Order" that the Bushes were for, a world- the United Nations- under one superpower: the United States.

How and when it will happen

In 1989 the Berlin Wall fell. This signified the beginning of the fall of the USSR, which was completed in 1991. Previous to this there were two world superpowers, bilateralism, these were the USSR and the USA. Once the USSR fell the USA became the sole world super power- unilateralism for awhile. In our time we are seeing two world super powers, which is bilateralism, Russia and the USA. But at the battle of Panium in 2021 Russia will be defeated and begin to fall, paralleling the USSR's fall in 1989. When the Sunday Law arrives, the fall of Russia will be complete, and the USA will again be the only superpower: unilateralism.
