Well now Trump passed some law that no foreigners can work in government agencies, so they are back to square one and they can only stay in the U.S. for two months without having a job. So they have one more month to find another job or else they will have to go back to India. They’ve been here since 2011 trying to get a green card and this only got worse after Trump came in. She’s been such a big help to me and others at the school since she started here; and if they go back to India they will also have a greater chance of catching COVID.” Not only is the law that was passed by Donald Trump affecting the lives of Sister Linda’s coworker’s family, but Sister Linda expresses that “It is affecting a lot of immigrants in their same position.” And this is a sad and horrible situation for many. He doesn't always see them or hear them when they come in and they don't take the time to have good communication with him as he has trouble hearing and needs the extra effort put forth from the staff to understand what's going on. It breaks Sister Elaine's heart to know how her dad is being treated as it does for the other elderly patients who are not receiving the compassion and affection they need and the company of loved ones at this time. Her dad was really hurt by the nurses who didn't treat him well. For the most part, He does fine while in the nursing home. But, it is Sister Elaine's prayer that he is blessed with nurses who show more compassion and care. And in a recent update, it seems that that may be working out for him as things may be changing as her dad's discontent and dissatisfaction is made known and aware of. Nevertheless, Sister Elaine prays that the Lord would make opportunity for some family limited visits as it seems as though his skin cancer is progressing. They were recently informed that the cancer has grown quite a bit—that it would get into his skull and then his brain. Her dad does not want any treatment. He only accepts drugs when it gets painful. So, it's Sister Elaine's desire that it may soon be possible for some family limited visitation, at least to sit with him just a little before his mind is gone. Let us join Sister Elaine in praying for the Lord to make things possible for some family visitation and that her dad is blessed with more compassionate and caring nurses. Thank you.</p>
